The Ministry of Health has received financial support from the Global Fund to Fight HIV, Tuberculosis and Malaria and intends to apply part of the funding towards payments under the contract of the Tender for Engagement of Consultant for the Development of mCervical Cancer Platform for the Ministry of Health.
2. The Ministry of Health, now invites sealed bids from eligible and qualified Consultants for the development of mCervical Cancer Platform for the Ministry of Health as per details provided in the Bidding documents.
3. Bidding will be conducted through Open National Selection procedures specified in the Public Procurement Act No. 12 of 2008 and the Public Procurement Regulations of 2011, and is open to eligible and interested Consultants as specified in the Bidding Documents.
