MOH/GFATM/ORD/004/18: TENDER FOR THE SUPPLY AND DELIVERY OF VIRAL LOAD (VL) EQUIPMENT AND CONSUMABLES.

1. The Ministry of Health has received funds from the Global Fund to Fight AIDS, Tuberculosis and Malaria under the New Funding Model (NFM) grant and it intends to apply part of the proceeds to payments under the contract for the supply and delivery of **VIRAL LOAD (VL) EQUIPMENT AND CONSUMABLES**.
2. The Ministry of Health now invites sealed bids from eligible and qualified bidders for the Supply and Delivery of Viral Load (VL) Equipment and Consumables as detailed in the bidding document.
3. Bidding will be conducted through the Open National Bidding (ONB) Procedures specified in the Public Procurement Act of 2008 and the Public Procurement Regulations of 2011 and is open to eligible and interested bidders as defined in the Bidding Documents.

A complete set of Bidding Documents in English may be purchased by interested bidders upon payment of a non-refundable fee of **ZMW 500.00** (Kwacha Five hundred) or equivalent in any freely convertible currency at the prevailing exchange rate. Purchase and collection of bidding documents shall be Monday to Friday from 08:00 hours to 16:30 hours. The method of payment will be **cash or Bank certified cheque**.
6. Bids must be delivered to and placed in the tender box at the address below on or before **10:00 hours** local time on **17th January, 2019**. Bids must be appropriately bound, sealed and labelled. Electronic bidding will **not** be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders or their representatives who choose to attend in person at the address

below immediately after **10:00 hours** local time on **17th January, 2019**. All bids must be accompanied by a **Bid Security (Bank Guarantee or Bid Bond)** of 2% (two percent) of the bid sum or an equivalent amount in a freely convertible currency.
